5.0 New Business

5.1 Teacher Academy Day Review

School of Education hosted a Teacher Academy event on December 9 that went well. There were 3 Teacher Academies that came to the event with approximately 51 students in attendance. It was a day that was structured to be instructional and informative as well as serve as a recruitment event. The event went smoothly and there are plans to do a similar event in the fall with more EPP involvement.

5.2 Data Reporting Process Change

As the EPP has built the QAS over the past few years and worked with CAEP, MDE, and other reporting process, it has become clear that our calendar for reporting needs to be edited slightly. The data review process will be the spring will serve as Data Review time for the entire EPP. The fall will be the time for implementation. This calendar will also serve for recruitment events. Events will be held in the fall and data review will happen in the spring.

5.3 Revisions to Key Assessments

Three recommendations have been made by the AAC (Assessment and Accountability Committee) and approved by Faculty and are being brought before the TEC for approval:

- 5.3.1 Impact on Student Learning Assessment: Remove Impact on Student Learning Assessment from ED 302 and first semester of ED 697. Have students submit certificate of Impact on Student Learning Training prior to doing the assessment in the course (ED 452 or ED 697-second semester)
- 5.3.2 10-Day Unit Plan
 The 10 Day Unit Plan will be removed from Internships (both Undergrad and MAT) and replaced with a 5 Day Unit Plan.
- 5.3.3 Video Reflection Revision
 The Video Reflection Rubric obtained unsatisfactory validity scores and after discussion from AAC has been replaced by another rubric.
 That rubric will be piloted Spring 2023 semester.

Dr. Brian Anderson made a motion to approve all Key Assessment Revisions and Dr. Stephanie DuGuid seconded. The motion carried.
