3. Committee Reports:

- a. Administrative Council (President Chisolm)
 - i. President Miller spoke about possible legislation that may be introduced during the next legislative session.
 - ii. Enrollment numbers should be released by IHL later today
 - iii. The Student Government Association issued a name change poll to students on campus. Currently, there is no official SGA stance on the issue.

 - Institutional Animal care and use committee needs to be instituted due to growth in biology department. Editorial changes need to be made to policy 1313 to reference misconduct in research.
 - ii. New changes coming to ACT scoring and testing. ACT super scoring will allow students to combine their highest sub-scores. Students will have opportunity to re-test in specific sub-score sections.
 - iii. Change to section 2.6 of undergraduate bulletin moving withdrawal policy to departments so students will have to talk to an advisor instead of going directly to the Dean.
 - iv. Policy statement 1312, willing to give the review responsibility to faculty senate.
- d. PIE Council (Secretary Childers)
 - i. No update. Members still reviewing assessment plans.
