Council Actions for October 6, 2017

College of Nursing & Health Sciences

Mark Bean and Katymay Malone presented the following proposals for H&K:

1. Modify an Existing Curriculum – Pre-Occupational Therapy

Based on the University of Mississippi Medical Center's requirements, the Pre-Occupational Therapy concentration will become a concentration in the Bachelor of Science degree in Kinesiology. Amanda Dahl made the motion to approve the proposal as presented with the change to effective date of Fall 2018. Josh Hanes seconded the motion and the proposal was approved unanimously.

2. Modify an Existing Curriculum – Sexual Health Minor

This proposal is adding FS 330 Human Sexuality and Socialization as an alternative to HED 110 Introduction to Sexual Health. Dee Dee Larson made the motion to approve the proposal as presented with the change to effective date of Fall 2018. Marty Hatton seconded the motion and the proposal was approved unanimously.

College of Business & Professional Studies

Scott Tollison presented the following proposals to make the designated adult completion program much more rigorous than some of the other institutions are doing in order to comply with IHL and the new Complete to Compete program.

3. Modify an Existing Curriculum – General Studies
a. Name change to Bachelor of Professional Studies

Changes to this program include the addition of a twelve (12) hour Professional Studies core and a new capstone seminar course (PSO 490) (if approved). Amanda Dahl made the motion to approve the proposal as presented. Dana Walker seconded the motion and the proposal was approved unanimously.

4. Offer a New Course – PRO 490 Senior Seminar in Professional Studies

This new capstone course will help students explore career opportunities and form connections between the chosen focus groups and integrate skills needed for employment in related professional fields.

Amanda Dahl made the motion to approve the proposal as presented. Josh Hanes seconded the motion and the proposal was approved unanimously.

Dr. Richardson expressed his appreciation to Dr. Tollison and his staff for preparing the proposal for the Bachelor of Professional Studies degree program and providing a program that will give students a substantial education.
