Council Actions for October 3, 2014

College of Arts & Sciences

Peppy Biddy presented the following proposal for Theatre:

- 1. Modify an Existing Curriculum Theatre Education Major
 - Add Teacher Certification Track

This proposal will be adding a teacher certification track to the B.A. in Fine Arts with Theatre Emphasis and will be the only program of this nature in the entire state. Dee Larson made the motion to accept the proposal as presented. Kim Whitehead seconded the motion. The proposal was approved unanimously.

Amber Handy presented the following proposal for the department of History.

2. Modify an Existing Curriculum – Social Sciences, BS and BA HIS 101 and 102 aren't required for General Education any longer but the B.S. and B.A. Social Sciences degrees still require them. This proposal was to remove the reference to "above 102" and replace it with "History must include 6 hours at the 300 level or above" for a total of 12 hours. Shelley Bock made the motion to accept the proposal as presented. Sade Meeks seconded the motion. The proposal was approved unanimously.

College of Education & Human Sciences

Mark Bean presented the following proposal for Health & Kinesiology:

3. Modify an Existing Curriculum – Pre-Occupational Therapy
The change was to modify the program to match admission requirements for
the University of Mississippi Medical Center Occupational Therapy Program.
Changes include: replacing the BSB 121 or BSB 303 requirement with BSB
141, replacing the EN 300 requirement with EN 102, and replacing 8 hours of
electives with 9 hours of electives excluding military science, religion, and 1
hour kinesiology skill electives, and adding requirements for MA 123 and BSB
142. Dee Larson made the motion to accept the proposal as presented.
Sally Pearson seconded the motion. The proposal was approved
unanimously.

Chad Murphy presented the following proposal for Health Education:

4. Create a New Course – HED 260 Patient Education This course will give students an introduction to theories that apply to the practice of patient education in a variety of health settings. Shelley Bock made the motion to accept the proposal as presented with the effective date being changed to Fall 2015 and a change of course number in the proposal from HED 299 to HED 260. This number is pending approval by the Registrar. Dee Larson seconded the motion. The proposal was approved unanimously.

College of Nursing & Speech Language Pathology

Tammie McCoy and Sheila Adams presented the following proposals for Nursing:

- 5. Modify an Existing Course NU 351 Clinical Practicum for NU 350
 - Name change to include practicum for NU 352
 - Change from 2 clinical hours to 4 clinical hours

The change was to combine NU 351 and NU 356 into one clinical practicum for both NU 350 and NU 352. Required hours for NU 351 increased from 2 hours to 4 hours. The College of Nursing & Speech Language Pathology has requested that this change be implemented for the spring semester 2015, and will be changed in the bulletin by the fall of 2015. Dee Larson made the motion to accept the proposal as presented. Chad Murphy seconded the motion. The proposal was approved unanimously.

6. Inactivate an Existing Course – NU 356 Clinical Practicum for NU 352
The change was to remove NU 356 as the required hours will now be
completed under the modified NU 351. Again, the College requested that this
change be implemented for the spring semester 2015, and will be changed in
the bulletin by the fall of 2015. Dee Larson made the motion to accept the
proposal as presented. Shelley Bock seconded the motion. The proposal
was approved unanimously.

Informational Items

It was suggested during the meeting that, if there happens to be a large increase in Pre-Occupational Therapy majors, it would be prudent to notify the Department of Sciences and Mathematics so they can anticipate increased enrollments in BSB 141, BSB 142, and MA 123.

The distribution of the proposals to committee members is now handled electronically through Microsoft Outlook Calendars rather than by submitting 15 hard copies to Lisa Lawrence.
