The Undergraduate Curriculum Committee met on December 2, 2011, in the Welty Boardroom. Irene Pintado called the meeting to order. The minutes of the November meeting were approved by a unanimous vote.

University Administration Actions

President Brigham approved the Council Actions from the November 4, 2011, meeting concerning the following:

1. Modify an existing curriculum: Change the title of the requirement for a “non-western” history course to a “global history” course to more accurately reflect the course selection to fulfill this requirement and to bring it in line with current terminology in university programs
2. Add a New Course – CA 385 Advanced Baking II which will provide a continuation of topics covered in CA 375 Advanced Baking (which will be renamed Advanced Baking I).
3. Modify an Existing Curriculum – Culinary Arts to include CA 385 as an elective and change CA 375 title to Advanced Baking I.
4. Modify an Existing Course – FN 302 Menu/Recipe development to add the prerequisite of CA 200 Introduction to Culinary Arts.

Council Actions for December 2, 2011

College of Education & Human Sciences

Dr. Angelia Taylor presented the following proposal for Psychology:

1. Modify an Existing Course – PSY 202 Global Psychology

The purpose of this proposal is to remove the prerequisite of PSY 201 Introduction to APA Style from the course. Amanda Dahl made a motion to accept the proposal as presented with the effective date changed to Fall 2012 and Rita Hinton seconded. The proposal was approved unanimously.

Dr. Donna White presented the following proposal:

2. Offer a New Course – PSY 210 Ethics of Psychology

This new course will cover cheating, law and lots of good information on ethics within psychology. Dr. Hinton was concerned that the title indicates a broader topic than is actually taught. It is not really an “ethics” course but a course that looks at a particular code of ethics. As this course is dedicated to the APA code of ethics, the title should be changed to indicate that that is the case. Dee Larson made a motion to accept the proposal as presented with a change in title to be Professional Code of Ethics - Psychology and the effective date changed to Fall 2012. Amanda Dahl seconded and the proposal was approved unanimously.

Old Business

New Business

Josh Hanes has worked extensively on attempting to put the UCC forms to fillable PDFs. As this process seems to be too time consuming for the novice, the committee is tabling this effort for the time being. There was discussion, but no decision made, of adding something to the forms that will indicate that they are the current forms. Also, there was discussion concerning tabling any proposals that are submitted on out of date forms. Work will continue on the revision of the forms and a process for getting rid of the old forms will again be initiated after approval.
