Council Actions for January 2008

College of Arts and Sciences

Rita Hinton presented the following proposals for English:

1. Proposal to Offer a New Course – EN 302 History and Structure of English Language

This course was formally EN 430. The course has been altered to include more discussion of the structure of English. In addition, the course has been given a new number (at a lower level), a new title, and a new course description. Cay Lollar made the motion to accept the proposal as presented. Patricia Dennis seconded the motion and it was passed unanimously.

Rochelle Hughes made the motion to accept these proposals as presented. Patricia Dennis seconded the motion and it was passed unanimously.

9. Proposal to Offer a New Course – EN 305 Advanced Grammar

This course was formally EN 301 Introduction to Linguistics. However, the needs of the English students will be better served by a course specifically in advanced grammar. The content lost in the move from Introduction to Linguistics to Advanced Grammar will be taught in History and Structure of the English Language.

Cay Lollar made the motion to accept the proposal as presented. Golda Vandiver seconded the motion and it was passed unanimously.

10. Proposal to Modify an Existing Curriculum -- English (English Major, English Major Creative Writing Concentration, English Major with Teacher Certification in English, and the TESL Certificate Program)

The change from Introduction to Linguistics to Advanced Grammar necessitates a change in the required courses for the English majors and English majors with a creative writing emphasis. Dee Larson made the motion to accept the proposal as presented. Rochelle Hughes seconded the motion and it was passed unanimously.

Marty Hatton presented the following proposal for Communications:

Proposal to Modify an Existing Course – COM 303 Images of Women in Film
 Cross-list as WS 303

This course will now be cross-listed as WS 303. This will increase the visibility of the women's studies courses. Cay Lollar made the motion to accept the proposal as presented. Lillie Smith seconded the motion and it was passed unanimously.

College of Education and Human Sciences

Holly Krogh presented the following proposals for Psychology:

 Proposal to Modify an Existing Course – PSY 350 Psychology of Women a. Cross-list as WS 330 352 UCC Minutes January 18, 2008 Page 7

Cay Lollar made the motion to accept the proposal with the following changes: the cross-listed number will be WS 352 instead of the proposed number of WS 330. Thus, the course will be cross-listed as WS 352. This change will increase the visibility of the women's studies courses. Golda Vandiver seconded the motion and it was passed unanimously.

Proposal to Modify an Existing Course -- PSY 425 Gender Development a. Cross-list as WS 425

This course will be cross-listed as WS 425. This change will increase the visibility of the women's studies courses. Donna Burlingame made the motion to accept the proposal as presented. Amanda Dahl seconded the motion and it was passed unanimously.

14. Proposal to Modify an Existing Curriculum – Psychology Curriculum

The change to the Psychology minor will clarify course requirements and resolve issues for students who have already taken PSY 201 (Introduction to APA style) as part of their major requirements. Dee Larson made the motion to accept the proposal as presented. Rochelle Hughes seconded the motion and it was passed unanimously.

15. Proposal to Modify an Existing Course – PSY 328 Adolescent Development

Cay Lollar made the motion to accept the proposal as presented. PSY 201 Introduction to APA Style, will now be a prerequisite or co-requisite for this course. The prerequisite is needed to better prepare students for the course and will allow faculty to spend more time focusing on the content of the course. Rochelle Hughes seconded the motion and it was passed unanimously.

Culinary Arts Institute

16. Proposal to Modify an Existing Curriculum -- Culinary Arts

Nutrition for Culinary Professionals was taken out of CA 399 and given its own course number, FN 326. Thus, FN 325 will be replaced with FN 326 (a course that is targeted specifically to culinary students) in the Culinary Arts Curriculum. Donna Burlingame made the motion to accept the proposal as presented. Lillie Smith seconded the motion and it was passed unanimously.

17. Proposal to Modify an Existing Course – ServSafe Certification

The grading scale of pass/fail will change. The grading scale will now be as follows: if a student earns a 75% or better on the test, he/she will receive a passing grade. If a student scores < 75%, he/she will receive a failing grade. Lillie Smith made the motion to accept the proposal as presented. This course will have a Pass/Fail grading scale. Cay Lollar seconded the motion and it was passed unanimously.

Honors College

Eric Daffron presented the following proposals from Honors:

- 18. Proposal to Offer a New Course HO 250 Great Books III: The Early Modern World
- 19. Proposal to Offer a New Course HO 252 Great Books IV: The Modern World

The Honors College plans to modify its curriculum and require HO 150, HO 152, HO 250, and HO 252 of all honors students starting in fall 2009. These courses will increase the offerings for honors students, many of whom already have prior credit for some of the current honors general education courses. Pat Donat made the motion to accept the proposal as presented. Rochelle Hughes seconded the motion and it was passed unanimously.

University Courses

- 20. Proposal to Modify an Existing Course CAAP Test

The course number will be changed to UN 399 because students confuse the current course number (UN 001) with UN 101: Introduction to College Life. Cay Lollar made the motion to accept the proposal as presented. Amanda Dahl seconded the motion and it was passed unanimously.

Old Business

Dee reminded the committee members to share the information from the committee meetings with their departments in order to facilitate any subsequent changes or proposals that need to be brought back to the committee. As it takes some time to get approvals, meeting minutes cannot be published immediately.

Policy Review – Pat Donat will rewrite the template for new course proposals to include student outcomes.

New Business

Dr. Jordan initiated a discussion about the need for a curriculum review to be submitted with future proposals. In many cases it is hard for the UCC to adequately review the individual proposals without understanding how the proposals fit into the overall curriculum plan for each department. Thus, it would be helpful to have a "curriculum map" included in the required elements for the proposal. A subcommittee comprised of Dee Dee Larson, Donna Burlingame, and Dionne Fortenberry will research the issue and make a presentation to the UCC in a future meeting.

In addition, Pat Donat would like for the UCC to consider adding a section to the proposal forms that will require the departments to include a statement in the syllabus/course objectives that specifically indicates student learning outcomes. The subcommittee will propose a specific statement in a future meeting.

The due date for proposals for the February meeting will be January 23, 2008. This is the last possible date for changes to be included in the 2008 catalog.
