**University Administration Actions**

President Brigham approved the Council Actions from the October 1, 2010, meeting concerning the following:

1. Modify an Existing Curriculum-Mathematics with Teacher Certification-Add MA 123 Statistics as a required course.
2. Modify an Existing Curriculum-New Minor-Public Health Education
3. Add a New Course-HKH 250 Professional Foundations of Public Health Education
4. Add a New Course-HKH 299 Special Topics in Health Education
5. Add a New Course-HKH 310 Social and Behavioral Aspects of Public Health
6. Add a New Course-HKH 320 Environmental Public Health
7. Add a New Course-HKH 330 Global Health
8. Add a New Course-HKH 450 Planning, Implementation, and Evaluation of Public Health

### **College of Education & Human Sciences**

Youn Mi Lee presented the following proposal for Education and Human Sciences:

1. Create a new course: FS 316 Issues in Families: Work and Violence. The proposal is to create a new course that will strengthen the Family Studies program. Donna Burlingame made a motion to accept with the revision that PSY 201 is a prerequisite. Rita Hinton seconded and the motion passed unanimously.

Dorothy Berglund presented the following proposal for Education and Human Sciences:

2. Modify an existing curriculum. Family Studies Major. The proposal is to add flexibility to the major by replacing the required course FS 351 Women's Experiences of Family Life with the option to select either FS 351 or the new course FS 316 in item #1 above. Dee Dee Larson made a motion to accept as presented. Deborah Miranda seconded and the motion passed unanimously.

Youn Mi Lee presented the following proposal for Education and Human Sciences:

3. Modify an existing curriculum: Family Studies Minor. The proposal is to modify the minor and increase flexibility. Dee Dee Larson made a motion to accept with the revision that the statement within the new curriculum "Choose two elective Family Studies courses (6 hours)" be replaced with:  
Choose two elective courses (6 total hours):  
Any Family Studies course  
PSY 302 Child Psychology

Deborah Miranda seconded and the motion passed unanimously.

### **Old Business**
