Council Actions for October 9, 2009

College of Arts and Sciences

Debra Atkinson presented the following proposal for Music and Theatre.

Modify an Existing Course- MUS 115 from Madrigal Singers to Chamber Singers.
The change in title of the course will better reflect the course content since they
sing more than Renaissance Madrigals, as reflected by the old name. Dee
Larson made the motion to accept the proposal as presented with the effective
date of Fall 2010. Cay Lollar seconded the motion and the proposal was passed
unanimously.

Ross Whitwam presented the following proposals for Science and Mathematics.

- 2. Modify an Existing Course- BSB 102 General Biology II.
- 3. Modify an Existing Course- BSB 102L General Microbiology Lab II. These proposals add BSB 101 and BSB 101L as prerequisites so that the courses should now be taken in sequence.
- 4. Modify an Existing Course BSB 310 General Ecology. This proposal adds BSB 230 and PSC 111 and 111L as prerequisites for the course since this class requires knowledge of both Chemistry and Genetics. The proposal was approved as presented. Cay Lollar made the motion to accept the proposals as presented. Dorothy Kerzel seconded the motion and the proposals were passed unanimously.
- 5. Modify an Existing Curriculum BS in Biology. This modification involves adding BSB 346 Evolutionary Biology as a required course, which in turn reduces the number of elective choices from four to three. The computer applications course will also be removed since content specific computer applications are incorporated into individual classes. Dee Larson made the motion to accept the proposal as presented. Dorothy Kerzel seconded the motion and the proposal was passed unanimously.

- 6. Modify an Existing Curriculum BA in Biology
- 7. Modify an Existing Curriculum- BA in Chemistry
 These proposals delete the degree programs since enrollment is traditionally low
 to none. Cay Lollar made the motion to accept the proposals as presented.
 Dorothy Kerzel seconded the motion and the proposals were passed
 unanimously.
- 8. Memo to change any course with a prerequisite of BSB 120 to the BSB 141 and 142 sequence since they have replaced BSB 120. Cay Lollar made the motion to support the change in prerequisites as presented. Dee Larson seconded the motion and the proposal was supported unanimously.

9. Informational item related to Appendix 7: Authorization to Plan a New Culinology Degree Program. This is a joint degree which will be offered between MUW's Culinary Arts Institute and MSU's Food Science, Nutrition, and Health Promotion Department. It was suggested that the number tables on the first page be corrected. Cay Lollar made the motion to support the item with the above mentioned changes to the number tables. Dee Larson seconded the motion and the proposal was supported unanimously.
