**Administrative/Biographical Notes:** In 1989 Clyda Stokes Rent was inaugurated as the twelfth and first woman president of the Mississippi for Women. She was a native of Charlotte North Carolina. She earned her B.A, M.S. and Ph.D. degrees in sociology from Florida State University. Before arriving at MUW she was associated with Queens College in Charlotte North Carolina. During her time as president, MUW experienced the Ayers Case; MUW applied for National Historic Landmark status there was substantial growth in student enrollment and funds. She was widely popular during her first years at MUW but her later years were marked with very controversial decisions that would lead to her resignation in 2001.

**Scope and Content Notes:** The collection is contained in twenty two boxes comprising of three series. The first series is her inauguration in 1989. The second pertains to the National Landmark and the last is the Ayers Case.

Series 1: The collection is contained in five folders which are contained in one box. Most of the collection is news clippings of her inauguration in 1989.

Series 2: In 1990 a second application was filed with the National Park Service to have the front of the MUW campus designated as a National Historic Landmark. This was collaboration between Clyda Stokes Rent, then President of MUW, The Mississippi Department of Archives and History, And Sally and Bruce McMillan. The first application was filed in 1965. Both were rejected.

The collection is contained in twenty folders which are contained in one box. Most of the collection is documentation on the History of the institution through the years and history and floor plans of the buildings that are listed on the National Register of Historic Places.

Series 3: Jacob Ayers filed a class action lawsuit vs. the governor of Mississippi, the Board of Trustees for Institutions of Higher Learning (IHL), the Commissioner of Higher Education, and others in the five historically white public Mississippi universities in 1975, alleging that the state maintained de facto segregation in its universities by inadequately funding historically black universities, a violation of the Equal Protection clause.



The case, *Ayers v. Allain*, was decided against the plaintiffs in the US District Court, but overturned on appeal and heard by the US Supreme Court in 1992. The court found that the state had not done enough to disestablish its old segregated university system.

From there the case was remanded to the district court, where the state proposed merging Mississippi University for Women with Mississippi State University, and Mississippi Valley State University with Delta State University, among other changes. In March 1995, presiding judge Neal B. Biggers Jr. of the US District Court for the Northern District of Mississippi rejected the proposed mergers, allowing the two universities to continue operations. An alternative set of remedies was settled upon, and the case was adjourned in 2002.

Collection includes the legal documents required by all universities in Mississippi involved in *Ayers* case to house in their libraries for public reference, which originally appear to have come from the office of Dr. Rent. Her notes also feature prominently. This series also includes grant information from same period. Three boxes include materials that appear to have been brought into Dr. Rent's office from the offices of Admissions, Academic Affairs, and Financial Affairs.
