

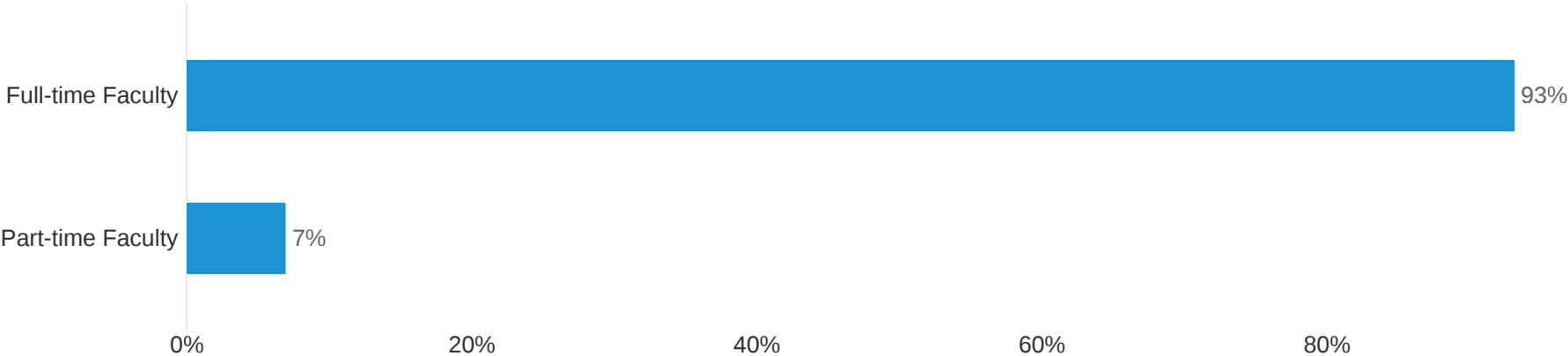
# 2024 MUW Faculty Satisfaction Survey

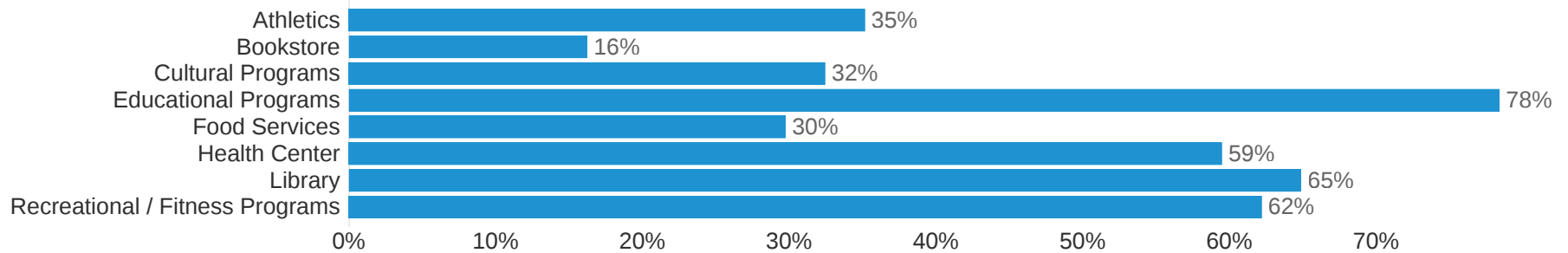
