Kim Whitehead presented the curriculums. She noted an omission under the planning process: [specify action here] should read "subsequently considered the proposal and voted unanimously to forward it to Graduate Council for consideration." She discussed the fact that there has been some discussion from the beginning in the Women's College of a graduate equivalent to the undergraduate program. She proposed that this program be available to all graduate students across all graduate programs. There are 2 levels within the programs, Scholars and Fellows with Graduate being added into those titles. The curriculum is very flexible with the Scholar's having to complete 4 Women's Studies electives and the Fellow's having to complete the electives and the experiential learning or research course with an additional requirement of presenting what they have learned through that course to undergraduates. The floor was opened to question for Dr. Whitehead. David Carter asked about whether the courses are online or face-to-face. She

stated that all of the courses are currently online. Dr. Dunkelberg stated that for international students they can be offered face-to-face. Marty Brock suggested these be looked at as a block for approval. The council agreed. Brian Anderson made a motion. David Carter seconded. All were in favor. None opposed.

Marty Hatton presented the new curriculum. This curriculum addresses those individuals who fall at both ends of the spectrum: Gifted and SPED (double exceptionalities). The course changes are ones where the faculty modified the course to include double exceptional factors. MED has changed from double exceptional to twice exceptional to multiple exceptional. The course modifications were written to address what the faculty needed to be updated in the program progression instead of just having the research bookend the program. Marty Brock asked if this had been submitted to IHL for approval yet. Marty Hatton stated it is pending Graduate Council approval but he did give it to Scott Tollison so if it is approved he can move it on. All courses are offered online. Ultimately though he would like for them to be offered as Hyflex. First motion brought forward, approve the curriculum: Master in Education for Multiple Exceptionalities. A motion was made by Amanda Clay Powers, seconded by Dee Dee Larson. All were in favor. Courses were brought forward in a block. Motion was made by Shonda Phelon and seconded by Catherine Cotton. All were in favor.

## II. Other/Discussion

- Approve October minutes Amanda Clay Powers moved to accept the minutes from the October meeting. Kelly Woodford seconded. All were in favor.
- Informational item-Speech Pathology licensure information Speech Pathology was previously listed under School of Education's reaccreditation but when reevaluation was done there was a change in leadership and Speech Path is now listed separately. Dr. Cotton has meet with Deborah with state department so that when speech path students graduate they will be qualified for the Department of Education and Department of Health so they can work in hospital settings and ASHA. This is a paperwork issue. No coursework or curriculum needs to be changed. Marty Hatton stated there is a new POC at MDE Deb Stoulig. He will send contact information to Dr. Cotton and Dr. Brock.
- Informational item: Program admissions letter revamp: Due Friday, November 22nd
- WP/WF Only IHL institute that has this grade other than MUW is Alcorn. All other colleges just have a W. The exceptions are MSU/USM. They have XF which is for an honor code violation, ie plagiarism, etc.
- Discussion on minimum GPA. Right now graduate studies is 2.75 for full admission or

3.0 on last 60 hours, with some programs having higher minimums. Currently, there is no minimum for conditional admission. Other institutes are across the boards. Discussion was tabled.

- Bulletin 7.8 time limitation discussion Our current language is "six years from date first enrollment." Technically, the beginning of the semester they first started taking classes. Our catalog language is in line with institutions. Marty Brock suggested adding a line to the bulletin 7.8 "Programs may have other time limitations." Dee Dee Larson motioned. Marty Hatton seconded. This discuss was tabled. Will discuss at next meeting
- Slate discussion-Our consultant is no longer with the company. We have a new consultant who is part time. The two programs we were piloting on Slate are now back on Fire Engine Red. Basically everything has been delayed. Hopeful that the application will be in place for Summer/Fall. There will be no pilot. Worse case, paper application forms. Please finish your review of admissions letter. Due by Friday 22<sup>nd</sup>. Tiffany will resend admissions letters to those she hasn't heard from. Should be able to build into the system the review of the applications. So think about who in your area is your admissions committee so we can build that into Slate so we can automatic it. The hope is to automate as many of the forms as possible. The automation should make it quicker to get students admitted as well. As we hear more, we will update the council.
- FE Red update by Kendall Dunkelberg. The company disappears December 31 but the system shuts down Dec 18<sup>th</sup>. It only allows a student to choose Spring 2025. He has a report set up to export everything and then to keep exporting everything until the end of December. If someone wants to defer, they need to get all their information in by early December or they will have to wait until the new system is up and running. He is concerned because some programs are usually accepting applications for Fall 2025 by now. Dee Dee Larson asked to get MBA's reference request email form letter (letter of recommendation, scale) sent to her in case all the information in FE Red is lost. MBA's is built into the system. Kendall Dunkelberg stated he would look into it.
