  - 1. Creating a New Curriculum – Certificate in Interdisciplinary Aging Studies
    - a. The Certificate in Interdisciplinary Aging Studies provides knowledge in the field of gerontology. The program is to equip students with multidisciplinary understanding of aging processes, policies, and services. With the student's major, this certificate program prepares students for careers working with older adults and their families and provides a foundation for further study in gerontology.
  - 2. Modifying an Existing Course – FSC 203
    - a. Add restriction to FSC 203, professional issues

  - a. To better prepare our teacher candidates for today's classrooms and obtaining licensure for early childhood education from the Mississippi Department of Education.
